

Haute Honeymoon Giveaway

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.

The "Haute Honeymoon Giveaway" promotion (the "Promotion") is sponsored by The Wedding Party Studio and Sanders Travel (the "Sponsors"). The Promotion shall be judged by The Wedding Party Studio (the "Judges"). All decisions by the Judges regarding this Promotion and these Official Rules are final. The Promotion begins at 11:59 PM Central Standard Time ("CST") November 1, 2009 and ends at 11:59 PM CST March 1, 2010. The Promotion is open to legal Texas residents who are 18 years of age or older at the time of entry and who are engaged to be married in 2010. Employees of the Sponsor/Judges, and its affiliates, their advertising and public relations agencies, participating promotional partners, and the members of their immediate families, general and limited partners, directors, officers, affiliates, representatives, agents, and each of their immediate families and households are not eligible to enter the Promotion.

1. How to Enter and Win. You may enter in 3 ways: (1) by mailing your complete name, address, city, state, zip code, home phone number, wedding date and private e-mail address to: *The Wedding Party Studio, 2422 Allen Street, Dallas, Texas 75204*; or (2) go to theweddingpartystudio.com/contest and enter online. (3) Come into The Wedding Party Studio at 2422 Allen Street, Dallas, TX 75204 and fill out registration form. Only one (1) entry per person during the entry period will be eligible for the drawing, as determined by name, address and/or unique e-mail address. Multiple entries by the same person, including those made electronically by one person using one or more e-mail accounts, may result in disqualification. No responsibility is assumed by Sponsor, partners, or other Promotion sponsors (hereafter collectively "Promotion Providers"), for lost, stolen, mangled, misdelivered, illegible, incomplete or late entries. Online entries will be declared made by the authorized account holder of the e-mail address submitted at the time of entry. "Authorized account holder" is defined as the natural person who is assigned to an e-mail address by an Internet access provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. All entries become the property of Promotion Providers and will not be returned to the entrant. All entries must be submitted with a valid e-mail account that may be identified with a natural person by appropriate independent means, including, without limitation, reverse domain name search. Potential winners may be requested to provide Promotion Providers with proof that the potential winner is the authorized

account holder of the e-mail address associated with the winning entry. For purposes of these Official Rules, "receipt" of any online entry will be solely determined when the contest Administrator's website server records the entry data. Any automated computer form reply or receipt (such as one confirming delivery of email) does not constitute actual receipt by Administrator of an entry form for purposes of these Official Rules. The Promotions Providers are not responsible for entries not received

due to difficulty accessing the Internet, computer glitches, telephone service outages, delays, busy signals, equipment malfunctions and any other technical difficulties. For mail-in entries Promotions Providers are not responsible for any entries, which are lost, late, illegible, misdirected, damaged, incomplete, and incorrect, or postage due.

2. Selection and Notification of Winners.

a. All entries received by 11:59 p.m. on March 1, 2010 will be included among all eligible entries received at time of the drawing. Drawing of the pool will be made by The Wedding Party Studio. Selection is subject to verification by the Judges of eligibility and compliance with all conditions.

b. The selected names will be announced on or after March 1, 2010 on theweddingpartystudio.com and reasonable efforts will be made to contact the individual by phone and or e-mail as included on the winner's entry form.

c. If the Judges are unable to contact a winner in a reasonable amount of time, the prize will be forfeited and a second name will be drawn or the prize may be withdrawn.

d. Winners must meet all conditions set forth in the Official Rules.

e. Odds of winning are based on the number of eligible entries received.

f. **Deadlines.** All online entries must be received by 11:59 PM CST on March 1, 2010 and dated on or prior to that time. Sponsor's computer is the official clock for the Haute Honeymoon Giveaway. All mail-in entries must be postmarked no later than March 1, 2010 and must be received on or before close of business on March 1, 2010. Entries received after the above deadlines are void and will not be eligible.

5. Prize Details.

a. A total of one (1) prize will be awarded. Prizes do not have cash equivalent, and alternative prizes may be offered at the discretion of the Prize Provider.

b. Prizes and or redemption instructions will be provided to winners in a reasonable time period after eligibility is verified. Prize providers are not responsible for awarding by a certain date.

c. The Approximate Retail Value ("ARV") of the prize may vary. Prizes do not include service charges, tips, taxes or any other expenses, associated with redeeming a prize. It is the winner's sole responsibility to contact the Retailer to ascertain what, if any, expenses are associated with redeeming the prize.

d. Any prize or prize certificate not claimed within **20** business days of

winning will be forfeited by the winner. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. The Wedding Party Studio is not responsible for the delivery of a prize or prize certificate.

e. There is no substitution, transfer or cash equivalent for prizes, except that Sponsor may, at its sole discretion, substitute prizes of comparable value or cash. The prizes are expressly limited to the item(s) listed on the Promotion page and do not include taxes.

b. Every participant agrees to be bound by these Official Rules. Sponsor, and its affiliates, participating sponsors/promotional partners, general and limited partners, directors, officers, affiliates, representatives, agents and their employees assume no liability or responsibility for the prizes once they have been awarded to the winning entrants. Additionally, each winner shall hold harmless Sponsor, its affiliates, their affiliated advertising and public relations agencies, participating sponsors/promotional partners, general and limited partners, directors, officers, affiliates, representatives, agents and their employees against and waive any and all claims of liability arising directly or indirectly from the Contest or prizes awarded.

c. Sponsor reserves the right, in their sole discretion, to cancel, terminate, or suspend this Promotion should virus bugs, non-authorized human intervention, or other causes beyond their control, corrupt or affect the administration, security, fairness or proper conduct of the Promotion.

d. Sponsor reserves the right to make changes in the rules of the contest, including substitution of a prize of equivalent value, which will become effective upon announcement.

e. By participating in the Giveaway, the winner(s) agrees(s) to have their name, voice, or likeness and photo submitted used in any advertising or broadcasting material relating to this contest without additional financial or other compensation, and where legal, to sign a publicity release prior to acceptance of the prize.
